# Pacific Northwest Proud Boys - Jake Farmer, Nick Boling, Travis Taylor, Mark Rupprecht

Rose City Antifa, working in conjunction with allied groups in the region, has obtained information on many of the Pacific Northwest-located members of the white nationalist, alt-right group known as the Proud Boys. Over the coming weeks, we will be publishing a series of articles detailing the Proud Boys' specific brand of organized hate, and the individuals who make up this rising "weekend warrior" gang, in order to alert the community about the threat that this group poses. Jake Farmer is a violent, racist, and particularly anti-semitic member of the Proud Boys who lives in the Vancouver, WA area. Farmer acts as the leader of the Vancouver regional chapter. In keeping with the Proud Boy custom of virulent misogyny and flexible moral standards, Farmer, like Robert Zerfing, has been sued for child support by a former partner. Farmer's hobby of traveling from Vancouver to Portland to incite violence may precede Joey Gibson's repetitious cycle of hate rallies by at least six months; on July 4, 2016 he traveled to Portland to attack anyone he felt was disrespecting the U.S. flag.

Farmer began to follow Joey Gibson in June of 2017, accompanying him to Olympia, WA to harass students at Evergreen State College while wearing Proud Boy colors. Like many other members of the Proud Boys hate group, Farmer continues to attend Joey Gibson's bigoted and violent rallies, but distinguishes himself by forgoing the Proud Boys' usual dog-whistle vocabulary in favor of overt and extreme expressions of racism, homophobia, misogyny, and anti-semitism.



\_Proud Boy Jake Farmer apparently believes that an obviously-fake antifa flyer is real. He seizes on this opportunity to act righteously indignant and victimized, and his performances elicits responses from his fellow Patriot Prayer followers: Proud Boy Jason James repeatedly fantasizes about shooting and killing anti-fascist activists who oppose the Nazis he rallies with; far-right YouTube bigot Leo Stratton pretends he is victimized by the fake flyer; Washington state Proud Boy and fantasy-caricature-artist Naphtali Moore spouts a homophobic slur while referencing the neo-Nazi slogan known as “the 14 words”; Proud Boy Russell Schultz celebrates fascist dictator Augusto Pinochet’s murder of political dissidents and displays the logo of the neo-Nazi organization Anticom; and violent Portland Proud Boy Jacob “JD” Stockton, also apparently fooled by the clearly-fake flyer, uses the alt-right epithet “cuck.”\_







*Proud Boy Nick Boling promotes a racist propaganda film by white nationalist demagogue Lauren Southern.*

In early February of 2018, Nick Boling was arrested in Washington state when he and a group of his obnoxious far-right bigot friends were asked to leave a bar and Boling subsequently assaulted a woman working there as a bartender.



On 2/3/18 at about 0030 hours Bellingham Police were dispatched to the [REDACTED] located at [REDACTED] in [REDACTED] an assault. Officers arrived and contacted the bartender, [REDACTED] and she advised officers that a group of men were being disorderly inside so she asked them to leave. One of the subjects who were among the disorderly crowd was later identified as BOLING.

BOLING became upset when he was asked to leave and came at her as if he was going to fight her and called her a "fucking cunt". He then spit on her. [REDACTED] was a witness to the incident. BOLING was later located and questioned. He advised police that he was treated unfairly inside the bar because of his political beliefs and that is why they kicked him out. He denied spitting on anybody inside. BOLING was arrested and booked into the Whatcom County Jail for Assault IV.

On 2/3/18 at about 0041 hours I was dispatched to the [REDACTED] located at [REDACTED] in Bellingham reference an assault. Dispatch advised that the suspect was possibly still at the bar. Officers arrived but the suspect had left. It was determined that the suspect had spat upon an employee. The suspect was described as a white male, medium height and weight, wearing khaki pants, a black pea coat, with a t-shirt that said [deleted as per 42.56.240.1] and a high and tight hair cut.

Officer [REDACTED] remained on scene with the victim, [REDACTED] and witness [REDACTED]. I checked the area and while on [REDACTED] near the WTA station I observed the suspect matching the exact description. I contacted him and gave him verbal commands until he was in a position where I could handcuff him safely. After he was placed into handcuffs I advised him that he was being detained for an investigation of an assault that occurred at [REDACTED]. The subject was identified as NICHOLAS BOLING (A1) via his Washington State Driver's License.

Officer [REDACTED] drove [REDACTED] my location and she identified BOLING as the suspect. Afterwards I advised BOLING that he was under arrest for assault, which was due to him spitting on an employee. I read him his constitutional rights and he said he understood. BOLING advised me that he was being targeted inside the bar because of his political beliefs. BOLING said that he is part of [deleted as per 42.56.240.1] that leans "far right". He said that he has been called names such as [deleted as per 42.56.240.1] and the like but he does not identify with those groups. He said that Bellingham is a very liberal town and he was being targeted by them. By them he specified that he meant the far left or "leftists". BOLING said that he was yelling at the bartender who was kicking him and his friends out. He said some spit may have gotten on her because he was yelling loudly but he said he did not intentionally spit on her.

I later contacted Officer [REDACTED] and she advised me that [REDACTED] advised her that BOLING had came at her in an aggressive manner and she was afraid that he was going to assault her. He then called her a "fucking cunt" and then spat on her a couple of times. See Officer [REDACTED] report for further.

BOLING was booked into Whatcom County Jail and issued a criminal citation for Assault IV (CB 098469). Nothing further.



██████████ stated a male patron spit on the bartender, ██████████, several times and was posturing like he was going to assault her.

I then spoke with ██████████ who confirmed that she confronted the male at the door way of the bar and was trying to get him to leave. ██████████ stated the male intentionally spit on her several times and said "Fuck you cunt" when she told him he had to leave. ██████████ stated the male then approached her like he was going to fight her. ██████████ stated the male was with a group of his friends who all eventually walked away from the bar. ██████████ stated someone followed the group to the area of ██████████.

The suspect was described as a white male, approximately 25 years old, 5'6" tall, wearing a "[deleted as per 42.56.240.1]" shirt, black peacoat and khaki pants with a high and tight haircut.

CSI ██████████ and Ofc. ██████████ detained a suspect matching that description on ██████████ near ██████████. I responded to their location with the victim, ██████████, to perform a show-up identification. ██████████ was able to positively identify ██████████ as the person who spit on her. ██████████ stated she was absolutely positive NICHOLAS BOLING (A1) was the person who assaulted her.

I informed Ofc. ██████████ of the positive identification.

Upon returning to the location that NICHOLAS BOLING (A1) was being detained, I overheard his explanation of the events of the night. NICHOLAS BOLING (A1) stated he was in a "[deleted as per 42.56.240.1]" who support the "[deleted as per 42.56.240.1]". NICHOLAS BOLING (A1) did not explicitly state he was a member of a gang and did not tell us the name of the club. NICHOLAS BOLING (A1) was also wearing a "[deleted as per 42.56.240.1]" t-shirt. A search of NICHOLAS BOLING (A1) on social media showed him posing for a picture with [deleted as per 42.56.240.1] (R3), who is the co-founder of the [deleted as per 42.56.240.1] chapter according to his Facebook page.



The following constitutes the official statement of the Pacific Northwest Proud Boys concerning inaccurate reports with respect to their plans for gay pride celebrations in the Portland area this weekend:

"The Proud Boys is a multi-racial men's fraternity that welcomes both straight and gay men as brothers. The only criteria for membership in the fraternity is that a person (a) be biologically male; and (b) recognize that the West is the best. The "West" refers specifically to culture and is not intended to assert the supremacy of any one race over another. Notwithstanding these facts, the Proud Boys recently been subject to a number of false and defamatory attacks. These attacks have included libelous assertions by the Southern Poverty Law Center that the fraternity is a "hate group" and have escalated to actual threats in the Portland area by domestic terrorists known as Rose City Antifa.

The facts are simple: The Proud Boys is not now, nor has it ever been, an anti-gay organization. The Proud Boys have not planned, nor are they intending to plan, any sort of action against the GLBTQ+ community in the Portland area or anywhere else. Our fraternity strongly believes in the right of *all* Americans to defend themselves. We condemn, in the strongest possible terms, the commission of violent acts against any person because of their race, gender, or sexual orientation. The only thing any person has to fear from the Proud Boys is the possibility that their presence may cause some establishments to run out of beer.






In October of 2017, Rupprecht almost hit a stopped car at 40 mph while driving drunk. While we don't like to mock individuals' issues with drugs or alcohol, this casual disregard for human life is endemic to the Proud Boys' activities both in daily life and as a group. That Rupprecht refused to comply with a sobriety test, and yet at the end still managed to thank the officer "for his service" when he was picked up from the police station by fellow Proud Boy Ethan Nordean, is perhaps a perfect example of the combination of nationalist fervor and violence that makes the Proud Boys the danger they are.



I was in full uniform and had a fully marked KCSO patrol car. I was on the scene of a two car accident along with Deputy Pritchett. We both had our overhead lights on and there were two cars blocking the northbound lane of travel on SE Kent Black Diamond Road in the 28800 block. I was wearing a bright green traffic safety raincoat and directing traffic around the scene.

I saw the violator car approaching from the south. He appeared to be driving over the posted 40 mph speed limit. I motioned him to slow down and pass through the scene in the southbound lane. He made no indication that he had seen me, continuing to drive at over 40 mph in the north bound lane. It appeared that he was going to strike the rearmost car. One person that had been standing near the truck saw the violator coming and ran to avoid being struck. I yelled for the driver of the stopped car to brace themselves for impact.

The violator vehicle slowed hard at the last moment, stopping less than 3 feet from the rear of the stopped vehicle.

I went to the driver's window and he rolled it down. I asked him if he was okay and he nodded. I could see his cell phone was on and sitting near the center console. It appeared to have directions on it as if it were being used for directions.

I could immediately smell the moderate odor of alcohol coming from within the car. The driver was the only occupant. He asked me "what's going on?". I told him that there had been an accident and that he nearly had another one. He made no comment. His eyes were watery and bloodshot.

I asked the violator if he was drunk. He replied "No - I'm a bartender". I asked where he was a bartender and he said "Yardbirds" in Des Moines". I pointed out that he was coming from the wrong direction and he add that he had just come from the Draft Choice Bar a bit south of our location.

(\* Yardarm Pub)

I again asked him if he was drunk or to impaired to be driving. He said "No".

I asked for his license and he retrieved it from a large pile of cards and cash. He did not seem to have a wallet.

His license identified him as Mark David Rupprecht.

Due to his driving, his odor, his eyes, and his slightly slurred speech, I told Rupprecht that I would like to do some FSTs with him to ensure he was safe to drive home. He was hesitant, saying that he didn't want to get in trouble. I explained that the tests were voluntary and that he didn't have to do them, as well as that if he started them he could stop them at any time. He nodded and I told him that if he wanted to try one I would have him say the alphabet. He agreed and confirmed that he was going to recite it. He began, but could not complete it accurately, replacing "V" with "Z".

I then demonstrated and described the finger dexterity test. I showed it to him twice and again told him it was voluntary. He tried the test but could not do it. He counted 1,2,3,4, 3,2,1, but ended up without touching his index finger.

I asked Rupprecht to step out of the car. He asked why and I explained that if he was willing to do additional tests that they would need to be done out of the car.

Once outside of the car I had him stand in front of his car on the level, dry pavement. I had him face 90 degrees to the car so his lights wouldn't bother him.



had a nystagmus onset prior to 45 degree deviation. I saw 6 clues on this test.

After again telling him that the tests were voluntary I instructed and demonstrated the one leg stand. He attempted to do it with his right foot lifted but could not get past "3". He swayed significantly and used his arms for balance. He laughed and said he couldn't count to 30. I asked him how high he could count and he said "3". I asked him if he wanted to try again and he did. In 2 more attempts he again put his foot down at "3". I saw 3 clues on this test.

I began to instruct and demonstrate the walk and turn test. Rupprecht interrupted me and asked me "Why are you doing this?" I asked him what he meant and he said that he was done, that "there is no need for any more". I asked if that meant he was too impaired and he shook his head. I clarified that he didn't want to do the test and he confirmed it.

I placed Rupprecht under arrest, handcuffing him and walking him to my car. I explained the process to him and asked if he had any prior DUIs. He said that he had none.

I retrieved his cards, money, and keys from his car.  
I had Pro Tow impound his car with a 12 hour hold.

I read Rupprecht his legal rights per department orders which he said he understood and invoked. (0246 hours)

I drove Rupprecht to Precinct Three, arriving at about 0259 hours. I placed him in a holding cell for a few minutes while I retrieved some paperwork.

At 0310 hours I checked his mouth and found nothing in it. His tongue was light brown with raised bumps, consistent with having consumed alcohol recently.

I had Rupprecht call a friend (Ethan) on his cell phone to arrange a pick up. I told Ethan where we were and that I'd be releasing him in about 25 minutes.

I began to complete the WSP DUI packet. When I asked him to sign the form after giving him the Driver's Hearing Request Information he refused to sign it. (0320 hours).

I read Rupprecht his legal rights from the form and he signed them. He declined to waive his rights at 0322 hours. I asked him if he wanted to talk to his attorney and he declined. I asked him twice more over the next few minutes and he declined each time.

I read Rupprecht the implied consent warning for breath. He refused to sign them at 0324 hours. He then said that he would not submit a breath sample, refusing the test.

I explained that I would still be releasing him (instead of jail) but that it would take a bit longer. I suggested that he call Ethan to delay his response. He asked why and I told him that I would be applying for a search warrant for his blood and testing, and that if approved, it would take about an hour to complete that task. He said "Fine".

I began to enter data into the BAC for the test or refusal. I again asked if he wanted to talk to an attorney and he said he wanted to talk to his friend. I told him to call but there was no answer. He then called his wife. He explained what was happening and then I spoke to her. I explained that we would call when we were done with the process. She told Rupprecht to blow in the machine, twice telling him that it would be better. I made no comment.

When I was done with the data entry I asked him if he would provide the breath samples and he agreed. He blew a .192 and .203 at 0336 and 0338 respectively.

I fingerprinted Rupprecht on the livescan machine. He became a bit confrontationally during this, asking me "why are you doing this?".

He was released to his friend in the front parking lot of the precinct. He ended the interaction by thanking me "for my service" and shaking my hand.
