CAMERON HEUGLY is a member of the Proud Boys, an avowed "Western Chauvinist" group, a barely veiled code word for white nationalist ideology. He has been seen at rallies in the northwest along-side open fascists, neo-nazis, and white supremacists. Recently, while harassing clients at planned parenthood, Heugly attacked pro-choice and anti-fascist demonstrators physically and with the use of bear-mace. His presence puts many of us in danger purely based on who we are and, as his personal history shows, represents an immediate material threat to any and all community organizing.

THE PROUD BOYS have become a prominent, violent force at white supremacist and alt-right rallies. At these far-right rallies, the members of the Proud Boys frequently attack anti-fascist activists and other community members, creating space for more overtly fascist groups to organize, acting as de facto body guards for groups like Patriot Prayer, Identity Europa, Cascade Legion, Daily Stormer Book Clubs, Patriot Front, and other white nationalist and fascist groups and individuals. Jason Kessler, organizer of the "Unite the Right" rally where Heather Heyer was killed, is a former proud boy.

WHEN NOT ATTACKING AND HARASSING PEOPLE OF COLOR, WOMEN, AND ANTI-FASCIST ORGANIZERS, THESE WHITE SUPREMACISTS HANG OUT AT BARS IN OUR TOWN, GO TO WORK HERE, AND GO HOME TO SLEEP AT NIGHT.

UPDATE: Olympia Proud Boy Cameron Heugly Fired




attempting to clean up pictures of his own face. Paranoid and scared now that his neighbors know who he is, Heugly changed clothes at one point before continuing trying to scrape fliers off poles and walls for a couple more hours. Around mid-day a friend called Heugly's boss who said he had been fired after his employer 'realized some things about him.'

We are encouraged by this small victory and amused by his humiliation but we will not let this go, we will not let our community forget, we will continue spreading information about this violent, misogynist, white supremacist and making it clear he is not welcome in our town.

Here are updated fliers about Heugly you can post in your neighborhood. If you know of another Proud Boy, white supremacist, or fascist in your area we hope you will take inspiration from our success and make their name and face known.

Fuck Cameron, fuck the Proud Boys, nothing is over.





Around midnight between Monday and Tuesday, a small group of friends set out walking through the east side of Olympia armed with wheat paste and nearly one hundred fliers outing local Proud Boy Cameron Heugly. The fliers included Heugly's picture, home address, work, and information about the danger he and the Proud Boys pose to our communities. We wheat

While it important to oppose the Proud Boys and other white nationalists at their public events, we also want to remember they have jobs and homes and lives that we can disrupt. White supremacists should not be allowed to hide in plain sight or quietly fade back into our communities between violent rallies. The action we took is easily replicable—you can out the fascists in your town, call their jobs to get them fired, and prevent them from organizing white supremacist violence from the shadows. This is only the beginning.
