


Meet Lake Stevens Proud Boy Guy William Betten Jr.



Bill is #6 in the now infamous Razzals group picture with chapter organizer **Justin Lux** (#10) that has been the subject of such controversy.



On his public Facebook Bill shares his obvious distaste for antifascists and his familiarity with the politics of white supremacist prison gangs. Bill claims that whites are the majority in the prison system however according to the U.S. Bureau of Justice Statistics in 2013 black males accounted for 37% of the total male prison population, white males 32%, and Hispanic males 22%. Math has never been a strong suit for Proud Boys.
