AFFIDAVIT

COMMONWEALTH OF VIRGINIA:
COUNTY OF HENRICO:

This day, Detective C.K. Walker, personally appeared before me, Yvette A. Via, Chief Magistrate for the County of Henrico, in the State of Virginia, and after first being duly sworn, orally related these facts to establish probable cause upon which warrants were issued for forcible sodomy as defined in §18.2-67.1 of the Code of Virginia (1950), as amended.

On 5.27.15 at approximately 0815 hrs C.G.C. (R01, G01) called police to report a sex offense involving her 11 year old son (V01). C.G.C. (R01, G01) goes on to report that sometime in August between 2011 and 2012 her son was in the presence of Demetrius COOPER (S01) who has been diagnosed with Bi-polar disorder according to family members when Demetrius COOPER (now around age: 20) (S01) attempted to perform oral sex on (then age: 7-8) (V01) in the bathroom located at (V01) reports that her son was not present on this date but a few months ago (V01) told C.G.C. (R01, G01) (his mother) about this instance and approximately 3 weeks ago told her (R01) that it was still bothering him (V01).

C.G.C. (R01, G01) reports that according to (V01) the situation was broken up when (V01) older brother burst into the bathroom and asked the two of them what they were doing but did not see anything improper. C.G.C. (R01, G01) was unable to provide any additional information about Demetrius COOPER (S01) as none of the family member associated with Demetrius COOPER (S01) will converse with C.G.C. (R01, G01) anymore.

C.G.C. (R01, G01) asked her husband several months ago to report this occurrence but he failed to do so. C.G.C. (R01, G01) is very concerned about (V01) as he has become angry and withdrawn after this incident and has received counseling that has not helped him. C.G.C. (R01, G01) is not separated from her husband and did not provide his information. CIS notified.

On August 19, 2015, a forensic interview was conducted of (age 11) at the CAC (101 E. Grace Street, Richmond, Virginia 23219) by Ms. Briana Valentino, and witnessed by Detective C.K. Walker. (V01) disclosed that approximately 3-4 years ago (day before he started 2nd or 3rd grade, he was unsure) his cousin, Demetrius Cooper performed oral sex on him twice at his paternal grandparents residence in a bedroom, and a bathroom at (V01) Road in Henrico County, Virginia. Additionally, he disclosed his cousin rubbed his genitalia, rubbed his arms, and kissed him on his face and lips. These acts would have occurred when the victim was age 7. The victim had not disclosed fully prior to anyone, as he did not know how they would react to his disclosure. The suspect is believed to have been between 16-18 years old when the events occurred, and he and his family were visiting from Chicago, Illinois at the time. The interview was DVD recorded (ADAMS). The victim will be entering into counseling services offered through the CAC. The suspect is believed to be in Washington State (unknown address/city) per the victim's mother.

After consultation with ACA Ashley D. Thompson, the fore-going information gave Detective C.K. Walker probable cause to obtain the two warrants for forcible sodomy against Matthew Demetrius Cooper.

He further stated that Matthew Demetrius Cooper was in this State at the time the foregoing offenses were committed and that he verily believes Matthew Demetrius Cooper committed said crimes.

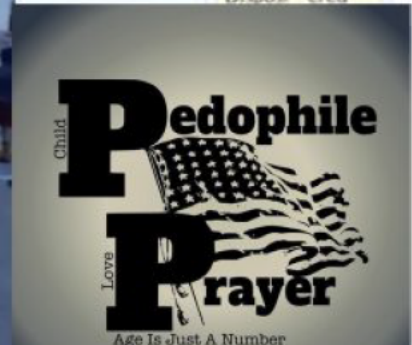

Joey has never disavowed PB or other violence perpetrated by his followers, and has now overtly begun to collaborate with Washington III Percenters, a hardline right-wing militia group, and a grab bag of violent ex-cons and thugs that include rapists and child molesters in an attempt to keep the violence alive during the absence of his old allies the Proud Boys.

Shortly after he began his grifting campaign of begging the masses of right wing lemmings for money, he purchased a home that lists a November 2017 sale price of \$470,000 in the Vancouver burbs.
